

## Membership Application 2023

This Membership Application (the "Agreement") is entered on this \_\_\_\_\_\_ day of \_\_\_\_\_\_ 2023 by you, the individual on the Shenandoah Valley Golf Club Membership Application.

## **EXPLANATORY NOTE**

Shenandoah Valley Golf Club, 134 Golf Club Circle, Front Royal, VA 22630 operates as a Semi-Private golf club. Member desires an opportunity to enjoy SVGC facilities on a regular basis and obtain certain privileges associated with being identified as a member of SVGC. Member agrees to become a Member on the terms and conditions set forth.

For good and valuable consideration, Member agrees as follows:

- 1. **Member.** For purposes of the agreement "Member" shall mean the person/persons identified on the "Shenandoah Valley Golf Club Application Form".
- 2. Membership. Upon payment of Membership dues, Membership privileges will be active for ONE year starting January 1 through December 31. Payment of Membership Fee does not give Member any right, interest or ownership in SVGC. Membership privileges are personal to member and may not be sold, transferred or otherwise assigned in any manner. Privileges shall cease and terminate upon death of Member. SVGC may revoke membership if Member violates the terms of this contract agreement. No portion of any fees paid is refundable upon revocation or suspension of the membership, other than as set forth below.
- 3. **Member Privileges**. For the duration of the Membership term, Member will receive certain benefits which may vary and are dependent upon the type of membership elected, these benefits are referred to as "Member Privileges". SVGC reserves the right to modify Member Privileges at any time.
- 4. **Membership Types.** SVGC offers three (3) types of memberships: Family, Individual and Weekday. Membership do not include Range Balls or GHIN Handicap but can be added for \$250 for a Range Plan and/or \$50 for GHIN Handicap.

- 5. Membership Payments. You may select two options of payments: In FULL by cash, check or credit card. Or divided into four (4) equal payments (January, February, March, and April), that will be charged automatically to the credit card on file. All membership credit card payments will incur a fee of 3% of the charged amount.
- 6. Family, Individual and Weekday. All membership types enjoy these privileges: unlimited golf including car, (1) month advance tee time reservations, and invitations to Member "ONLY" tournaments and events. Members are entitled to a 15% discount on all merchandise, (excluding sale items and golf balls and gloves) in our award-winning golf shop and receive a 10% discount on food items purchased in the Grill Room. All merchandise and Grill Room purchases may be charged to your member account. A credit card in good standing must be on file and all charges to accounts will be charged to credit card on file on the last day of each month. SVGC will not charge a 3% fee on membership monthly charge accounts.

**Family Memberships** are for an Individual and their legal spouses and dependent children (up to 21 years of age, living at home who are full-time students.) College identification cards and/or picture identification cards are required. The fee for this type of Membership is \$2,925.00 annually, which includes Membership Dues and Golf Car.

**Individual Membership** is a seven day a week membership for an individual person and the fee for this type of membership is \$2,325.00 annually, which includes Membership Dues and Golf Car.

**Weekday Membership** is for the individual that will only be playing during the week. This entitles you to be able to play anytime Monday-Friday. The fee for this type of membership is \$1,925.00 annually, which includes Membership Dues, Golf Car. Play on weekends and holidays will require a \$20.00 Fee.

- 7. Use of Golf Cars. As a rule, golf cars are allowed on the fairways, however, inclement weather or other conditions may evoke further cart restrictions. The golf staff will notify Members of any temporary restrictions, but players are expected to refrain from driving golf cars where it may damage the golf course or golf car. No more than two cars per foursome are allowed unless authorized by the Pro Shop. No more than two riders and two golf bags per car.
- **8. Golf Car Agreement:** I represent that I am familiar with the operation of this golf car and agree to return said car at the end of play in as good condition as received. I agree to hold SHENANDOAH VALLEY GOLF CLUB free and harmless from any damages or claims whatsoever arising from my use of said car, and further agree to pay for all damages sustained while said car is in my possession. I further represent that I am over 16 years of age.
- 9. Early Termination or Suspension of Membership. In the event that Member (a) becomes disabled, sick, or injured for a period exceeding thirty (30) continuous calendar days, (b) is activated for Military service, or (c) is relocated for business more than fifty (50) miles from SVGC and more than fifty (50) miles from Member's address set forth on Member enrollment form, SVGC may suspend or terminate Member's membership. In the event of disability, injury or illness, or death. Member must provide a doctor's note to SVGC. In the event of Military service, Member must provide a copy of military orders from issuing authority. In the event of relocation, Member must provide a copy of a utility bill or other correspondence to demonstrate new domicile. In the event of suspension, SVGC will not issue any refund, but will freeze membership for the suspension period. Decisions regarding early termination or suspension of membership will be in the sole and absolute discretion of SVGC.

10. **Monthly Charge Accounts.** I understand and acknowledge receipt of the documents ("Membership Agreement"). I have had the opportunity to review the terms of acquiring a membership.

I agree to pay all fees, dues, and other charges for which I am responsible under the terms of this Membership Agreement on or before the due date.

I agree to pay all Pro Shop, Grillroom and Beverage Cart charges on the last day of each month. I also agree to allow Shenandoah Valley Golf Club to keep my current credit card on file for such charges.

I agree to be responsible for all charges incurred by my family members and guests while using the Club facilities.

I understand that delinquency in paying any amount due will result in a 2.5% late payment fee on the amount past due. I also acknowledge that delinquent amounts may result in suspension or termination of my charging privileges at the club.

I hereby acknowledge receipt of Shenandoah Valley Golf Club's Membership Agreement that I have read and understand, and agree to be bound by the terms and conditions thereof, including any amended forms issued from time-to-time by SVGC.

This Membership Agreement may not be amended or modified, nor shall any waiver of any provision hereof be effective, except by an instrument in writing executed by the undersigned and the Club.
